# 2021 GOLF CART/ATV RULES AND REGULATIONS

The information listed within provides guidance regarding the valid usage of golf cart or atv type vehicles hereinafter referred to as golf carts/atv's at West Virginia Motor Speedway. Operators of golf carts/atv's understand that they do so at their own risk, and will relieve and hold harmless WVMS for any and all debts that might occur from theft, accidents, and/or injuries involving the use of the golf cart/atv. These regulations have been designed to provide a safe and friendly environment for all persons attending events at West Virginia Motor Speedway. Thank you for your cooperation.

Wood County Sheriff Steve Stephens issues this reminder- West Virginia Motor Vehicle Law may PROHIBIT golf carts/atv's from being on ANY public roadways at ANY time.

~ Violators may be cited and fined accordingly.

### A. **GENERAL RULES**

- 1. Operators must be 16 or older and hold a valid driver license.
- 2. Must have proof of insurance. Insured listed on the proof of insurance should match that of the individual registering for the permit.
- 3. All golf carts/atv's must be registered with WVMS for access inside the speedway fencing. Registration permit is \$25 for the season unless accompanied by a race team.
- 4. All golf carts/atv's must prominently display WVMS ATV permit on the front of unit at all times.
- 5. Golf cart/atv and driver must be present to receive a permit from Campground office.
- 6. Golf carts/atv's intended to be used after dark shall be equipped with headlights or other sufficient lighting sources.
- 7. Quiet Time is from 12am -7am. Golf carts/atv's must obey quiet time rules.
- 8. Curfew Time is from (1:00am-7:00am). NO Golf carts/atv's will be operated during curfew time as announced by WVMS officials. Any cart/atv moving during curfew times is a

violation of the rule and may result in loss of privilege and/or confiscation of the cart/atv till end of event which it will be impounded by security and/or local police departments.

### B. OPERATION OF GOLF CARTS/ATV's

- 1. DO NOT operate in a manner that may endanger passengers and/or any other patrons on the grounds of WVMS. Maximum Speed Limit is 5 mph. Excessive speeds will not be tolerated. Operators must yield to pedestrians at all times.
- 2. DO NOT operate golf cart/atv while under the influence of alcohol. It is against the law!
- 3. DO NOT overload of passengers on golf carts/atv's. No hanging, No riding, No standing
- the number of seats equal the maximum number of passenger(s).
- 4. Golf carts/atv's are restricted to the designated driveways and paths within the parking lots of West Virginia Motor Speedway and designated roads in camp grounds. There shall be no driving on public roadways, landscaping, etc.
- NO DRIVING ON THE ACTUAL RACETRACK OR ANY OTHER WVMS PROPERTY NOT SPECIFICALLY DESIGNATED FOR GOLF CART/ATV ACCESS!
- 6. Rental golf carts / ATV's will also obey by all rules and regulations set forth.

### C. PARKING REGULATIONS

- 1. Golf carts/atv's can only be parked within areas designated by proper signage and/or as announced over the West Virginia Motor Speedway public address system.
- 2. Golf carts/atv's must be parked within these areas in such a fashion that they do not block or impede entrance to buildings, stairways, or designated handicapped areas.

Violation of these regulations will result in revocation of privileges and operating permit and may result in golf cart/atv being impounded for the remainder of the event, and possible expulsion of the operator from the property with NO REFUND. WEST VIRGINIA MOTOR SPEEDWAY IS NOT RESPONSIBLE FOR ANY ACCIDENTS-INJURIES- THEFT ASSOCIATED WITH THE USE OF A GOLF CART/ATV AT THE SPEEDWAY.

TO RECEIVE ADVANCE ATV/GOLF CART PASSES YOU MUST REGISTER AT LEAST SEVEN DAYS (7) PRIOR TO THE SCHEDULED EVENT.
